

# Ashby Public School Student Pledge for Device Use 2023 - 2024

- I will use my device in appropriate ways that meet Ashby School expectations and are educational.
- I will use appropriate language when using e-mails, journals, wikis, blogs, or other forms of communication. I will not create or encourage others to create discourteous or abusive content. I will not use electronic communication to spread rumors, gossip, or engage in activity that is harmful to other persons.
- I understand that my device is subject to inspection at any time without notice.
- \*\* I will follow the policies outlined in the Technology Procedures and the Acceptable Use Policy while at school and outside the school day.
- I will take good care of my device; I will never leave my device unattended, I will never loan out my device to other individuals, and I will know where my device is at all times.
- I will charge my device daily and arrive at **school with my device charged for the day.**
- I will keep food and beverages away from my device since they may damage it.
- I will not use the device camera to take and/or distribute inappropriate or unethical material.

## The following are specific to school-owned devices:

- All One2One devices are the property of Ashby Public School. Students have NO ownership, interest, or right to title in the One2One devices.
- I will not disassemble any part of my device or attempt any repairs.
- I will not make changes to the system or add or remove software without the approval of the school.
- I will protect my device by only carrying it while in the case provided.
- I will not place decorations (stickers, markers, etc.) on my device or provided case.
- I will not deface the serial number or any other labeling on my device.
- I will file a police report in case of theft, vandalism, and other acts covered by insurance and report to the administration of Ashby Public School.
- I will report any issues with my device to the school in a timely manner.
- I will be responsible for all damages or losses caused by neglect or abuse.
- I agree to return the device, case, and power cords in good working condition, as directed by the school.

**\*\* I agree to the stipulations stated above and the Acceptable use policy in the Student Handbook. I further understand that any violation of the policies is unethical and may constitute a criminal offense. Should I commit any violation, my access privileges may be revoked, school disciplinary action may be enforced, and/or appropriate legal action may also be taken.**

**Please select one of the three options below:**

**Option 1: Purchase Insurance -**

Purchase the school-provided insurance for a \$20 fee, with deductibles of 1st use - \$10, 2nd use - \$30, & 3rd use - \$40. We understand that this policy covers one (1) device that is the property of Ashby Public School for one student for one school year. **I also understand that by purchasing this insurance, we are still responsible for any costs due to misuse, theft, loss, or vandalism.**

**Option 2: Decline Insurance - (Not recommended)**

We opt to decline insurance coverage. We understand that we are responsible for all costs incurred for any damage to the device that is the property of Ashby Public School described within for the prescribed student. FYI- Approximate typical repair costs: Power adapter ~\$25, Replacement touchscreen \$100+

**Option 3: Use a Personal Device -**

We do not wish to use a school-provided device and will use a **school-approved personal device**. Personal devices must have a physical keyboard and be a current Windows, Apple, or Chromebook laptop with a minimum of 10.7" screen. Devices may need district software installed & running while at school.
